



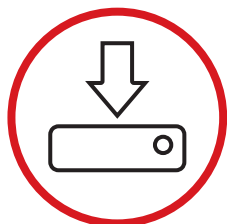

The use of NFC Track chips, readable via smartphone, will further help in the identification of PPE, showing the product data such as serial number, production date or date of first use.

PPE Database

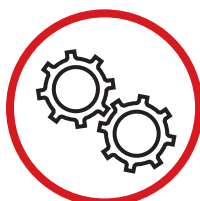

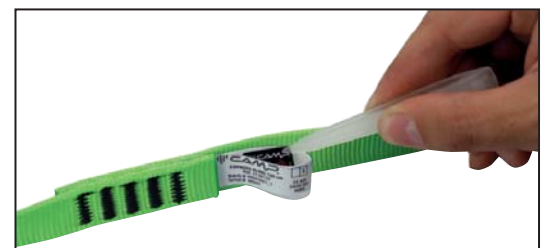

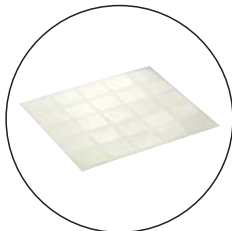
